Good afternoon Steve,

I hope you are well and thank you for your patience whilst I made enquiries for the below. I wanted to ensure the lighting team had all the information necessary before providing you with an estimate for switching to LED.

The lighting team informed me all 7 lighting units in Glynde are attached to Distribution Network Operator (DNO) assets, and we usually advise local parishes to remove their lanterns from these assets and replace them with a lighting column. This would cost approximately £2000 per unit. We understand this is a high cost, so the team also looked at the cost of replacing bulbs only. The lighting team used maps to look at the assets and have suggested the brackets look to be in reasonable condition, however, Unit B (pictured below) would require a new bracket. If we were to replace all lanterns in one job, including the one bracket (unit B), the total cost would be approximately £3,700 and the only risk of additional costs would be the control boxes. Please see images below of a typical installation in Glynde and another of Unit B that needs the new bracket.

Additionally, we are hoping to have the new agreement signed with you shortly. The legal team have raised a query regarding indemnity insurance which needs to be dealt with before we can sign it off. I apologise for this delay. As with most legal processes, they can take some time!
